TERMS & CONDITIONS: -

In case of change in the fee structures the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipt of fees/funds to the students.

Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the 12. committee.

The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply 13. the information to the Govt./ Department as required.

In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 14. 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.

School will provide ramp within six months. 15.
